Jobs created and supported **39,430**

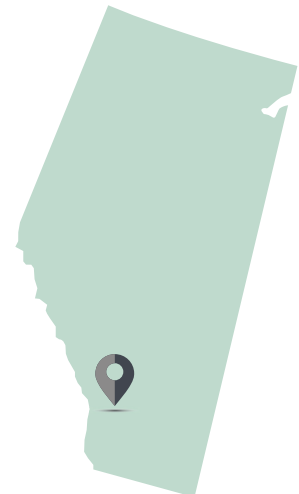
