SUBJECT: 2022 Legislative Session – Week 8 (February 28 – March 4)

In the final stretch with only one week of session left, legislators are pushing through bills involving alimony reform, smoking bans, and tourism. Budget conference started this week with some successful negotiations between the House and Senate budget chiefs, while some issues remain unsolved. The legislative redistricting process is closing but the congressional maps are still up for debate. Time is ticking down with the 2022 Legislative Session coming to a scheduled close on Friday, March 11. These and other topics are covered in our summary of the week in Tallahassee.

NAIOP Activities

Budget conference was announced on Monday late afternoon and began in earnest Tuesday morning. The unresolved issues bumped to the overall appropriation chairs on Thursday evening. At the time of this memorandum, the process was still ongoing with issues like the “water list” and “PECO list” yet to be released. As reportedly previously, the business rent tax issue will be tied up in the tax packages. The House tax package debuted two weeks ago, and as expected, it did not include a business rent tax. We are working with the Senate to add a BRT reduction.

Below are reports on other issues of importance to NAIOP.

Bi-Directional Amplifier Systems – Senate Bill 1190 and HB 785 will create exemptions to fire radio antennas for apartment complexes. Your NAIOP lobbying team is working on a potential amendment to add an additional extension on the deadline to comply with the state’s fire radio antenna requirement. The Senate version passed, already passed on February 23, was passed by the House on March 4. It is now set to be delivered to the Governor.

Business Rent Tax – With the major reduction in the business rent tax adopted during the 2021 legislative session, there has not been a major appetite to further reduce the tax during the 2022

legislative session. With the House package released, and not including a BRT reduction, your GR team has been working with the Senate to seek a reduction.

Government Mandated Electrical Charging Stations – There is no present legislation to preempt the regulation of electrical charging stations. However, there is legislation that would put requirements in for charging infrastructure. As well, there is legislation that pertains to development, which could be amended to restrict these regulations. Both are listed below.

Electric Vehicle Charging Infrastructure – SB 918 (Brandes)

Local Government Land Development Actions – HB 739 (Borrero) and SB 1248 (Gruters) – The House bill is moving, but the Senate bill is stalled. Lobbying team is working with the sponsors to explore options.

Surfside Legislation – The House finally debuted its response to the Surfside tragedy and it is mainly focused on condominiums. The bill passed unanimously in the House on Thursday, Feb. 24. It is STILL waiting for the Senate to take it up.

Condominium and Cooperative Associations – HB 7069 - Revises & provides laws for condominium & cooperative associations relating to disciplinary action, official records, reserve accounts & studies, recertification & phase 2 inspections, written recertification & phase 2 inspection reports, transfer of control of association, information that must be provided to potential buyers, & information included in prospectus or offering circular.
Effective Date: July 1, 2022

Florida Building Commission – After last session's major overhaul of the Florida Building Commission (and NAIOP's successful effort to save the BOMA seat), there has been minimal legislation addressing the Florida Building Commission. This issue appears to be better suited for 2023 legislative session.

Private Provider/Building Inspects/Building Certifications – There is an omnibus bill moving in both the House and Senate that we have been supporting on behalf of NAIOP. The summary of the legislation is below.

Building Inspection Services/Building Regulation – HB 423/SB 644 – The legislation does the following (CONGRATS! This bill passed both chambers last week on March 4. The House version is now headed to the Governor.):

Relating to building officials, building inspectors, and plans reviewers, the bill:

- Provides that a person may sit for the building inspector or plans examiner licensure test by completing a 4-year internship with a private provider or a private provider's firm, while under the direct supervision of a licensed building official, engineer, or architect.

- Requires the BCAIB to create a rule allowing partial completion of an internship program to be transferred to any other authorized internship.
- Prohibits the BCAIB from issuing a provisional license with a special condition or requirement that such licensee be employed by a municipality, county, or other local government agency.

Relating to private providers, the bill:

- Provides that if a person uses a private provider, the local government must provide equal access to all permitting and inspection documents and reports to the private provider, the owner, and the contractor.
- Defines “reasonable administrative fee.”
- Provides that if a notice of deficiency is not issued within two business days of receiving a request for a certificate of occupancy from a private provider:
 - A certificate is “automatically” granted, instead of “deemed” granted;
 - The building permit is closed; and
 - Local building officials must provide the permit applicant with a written certificate of occupancy within 10 days.

Summary of Week Eight (February 28-March 4)

Notable Topics

Miya’s Law

After unanimous approval on the floor, Senate Bill 898 by Sen. Stewart now awaits the House floor. This measure calls for apartment owners to conduct an extensive criminal background check on employees who can enter apartments, to give tenants at least 24 hours’ notice before entering an apartment, and to institute rigorous controls over master keys to apartment units. Senator Stewart took on this bill after an incident in her district where a college student, Miya Marciano, was murdered by a maintenance worker who entered her apartment with a master key. The companion bill, House Bill 577, has been stripped of most of the provisions, with only the 24-hour notice protection remaining. Stewart hopes the House will adopt the Senate version before voting and sending the bill to the Governor’s desk.

Redistricting

The Florida Supreme Court has approved the new state legislative maps. Following redistricting, every seat in the Senate goes up for election. The map has eight incumbent Senators living in the same district as their Senate colleagues. To resolve this, it is believed that Sen. Baxley will move out of the new District 9 and run in the new District 13 which avoids a Republican primary against Sen. Perry. The Legislature passed two congressional maps with the primary map reshaping the 5th congressional district (Tallahassee to Jacksonville) configuration to a Duval County-only seat.

The secondary map, which maintains a district similar to CD 5, serves as a backup option if the first map is found to be unconstitutional. On Friday, the Governor told Floridians he intends to veto the map.

VISIT Florida

An extension to VISIT Florida, the state's tourism marketing program, sets the expiration date to October 1, 2028. Currently, the sunset clause is set to expire on October 1, 2023. Senate Bill 434 by Sen. Hooper originally strived for eight years, but after the House amended it to five years, the Senate accepted their version. Rep. Chaney reminded members, "We still have control over the budget for VISIT Florida, we still have oversight." Conversations are ongoing on how to fund this program. Senate is looking to give \$50 million in recurring funds, while the House prefers to give a nonrecurring \$50 million.

Smoking Ban

On Wednesday, Senate Bill 224 which allows cities and counties to regulate the smoking of cigarettes and plastic-tipped cigars in parks, including beaches, was passed by the Florida Legislature. The bill sponsor, Sen. Gruters, received opposition from the original proposal that included cigars. An approved amendment narrowed the legislation down to fix this problem by focusing on cigarettes and filtered cigars. To align with the Senate, the House amended their version (House Bill 105) to also include this carveout. The reason for this measure was to cut down on pollution and litter, "It helps the environment by removing the bad butts off the beach," Gruters stated. It is now up to the decision of Governor DeSantis to become law.

Ending Permanent Alimony

Senate Bill 1796, that would repeal court-ordered permanent alimony and replace it with bridge-the-gap, rehabilitative, and durational alimony, is now headed to the floor. The bill sponsor, Sen. Gruters, believes his bill is an improvement on previous efforts for alimony reform. Critics questioned the retroactivity of the bill and in response, Sen. Gruters said that it "is not retroactive or unconstitutional." Other criticism included that cutting permanent alimony would leave individuals caring for children in tough positions. An amendment that would provide parameters to the court to make determinations regarding the duration and amount of alimony was approved in its Judiciary committee stop. The House version (House Bill 1395) awaits its hearing on the floor.

Budget Conferences

The first budget conferences started this week with the Senate and House negotiating on discrepancies in the final budget. The chambers have agreed on \$10 million towards Florida Highway Patrol driving range, \$5 million for the Pathways to Career Opportunities Grant Program, \$1.5 million for Pinellas County Science Center revival, and \$1 million for OCEARCH Mayport Research and Operations Center project. However, the Senate is still holding out on \$92 million

to modernize unemployment site while the House holds out for a \$75 million cut in Medicaid funding. Eliminated from the budget was \$120 million for the Moffitt Pasco site infrastructure.

Seizure Action Plan

Receiving bipartisan support, Senate Bill 340 by Sen. Garcia allows parents to draft an individualized seizure action plan that school staff can follow if their child experiences a seizure. Under this legislation, school employees will attend training to care for students with this submitted plan. Sen. Garcia, who herself has suffered seizures before, states “creating awareness with regard to children with epilepsy and seizures is very important.” The companion bill, House Bill 173, had already passed the House floor and the Senate substituted it in place of SB 340. It is now in the hands of the Governor.

Foreign Contribution Ban

House Bill 921 by Rep. Drake would ban contributions from foreign governments, foreign political parties, foreign businesses, and foreign citizens. Democrats supported this provision, however they opposed the restrictions on out-of-state entities within the bill. This includes limiting non-Floridians from donating more than \$3,000 and out-of-state political committees from receiving donations worth more than \$3,000 regarding ballot initiatives in the petition gathering process. Democratic Rep. Travis said the changes “...are being put in place to make it impossible for citizens to pass their initiatives.” Despite opposition, it has cleared the floor with Rep. Grieco crossing party lines on the vote. The Senate will now consider this measure.

Last Week Procedures/Rules

The number of bills available for lawmakers to consider shrinks after today. House Rule 10.18 says that after the 55th day, the House can no longer take up bills on second reading, meaning any House bill that is going to get a vote must already have been rolled over to third reading. Much of the final week of session will be taken up with bills that have already passed one chamber or the other and are in messages, or are bouncing back and forth between the chambers as they pass amendments. Any amendments made must be signed off on by the other chamber.

There are rule changes affecting amendments that come into play after the 55th day as well, with floor amendments required to be filed no later than two hours before the start of session and amendments to floor amendments and substitute amendments required to be filed by an hour before session.

In addition to bills on third reading and messages, the Legislature will have to take up a finalized budget this week.

72-Hour Review Period Before Budget Vote

The state constitution's Article III, Section 19 covers the budget, requiring a 72-hour public review, or "cooling-off" period, before a final vote once the budget is agreed to by conference committees. The idea was that after a conference process that can sometimes be murky for non-conferees, other lawmakers and the public should have time to see what ended up in the budget before a final vote.

Exactly when the 72 hours starts has become a bit fuzzier over the years as technology has changed. The constitution simply says general appropriation bills "shall be furnished" to lawmakers (and some others, including the governor and Cabinet members) at least 72 hours before final passage. The Legislature expands on the requirement in Joint Rule Two, which says the 72-hour period "shall begin to run upon completion of the furnishing of copies" of the budget to the required recipients. In earlier years, that meant once a paper copy of the budget was placed on every lawmaker's desk. The rules now say that while copies may still be placed on the desks, the budget also can be distributed electronically and then the time period can start. Under the rules, "an electronic copy is deemed to have been made available when it is accessible via the Internet or other information network ... ordinarily serving the members of the Senate or the House."

In any event, the Joint Rules also say that the speaker of the House and the Senate president must announce the completion time on the floor and it must be recorded in the journal so everyone knows when the final vote can take place. The Joint Rules also say that Saturdays, Sundays and holidays are included in the ticking off of time under the rule. For budget implementing and conforming bills, the required review period is only 24 hours.

The "Sprinkle List"

A somewhat opaque part of the legislative budget process is an additional pot of anticipated state revenue not included in initial negotiations over the budget. Setting aside the money allows for legislative leaders to fund personally-sought projects or other last-minute spending that didn't appear to make the cut in the regular budget process. That fund over the years has been known around the Capitol by many names, including the "bill pot," the "leadership fund," and the "bump fund," and the list of projects has come to be known as the "Sprinkle List."

Last year, the Senate withheld \$165.5 million and ended up funding an additional 115 projects and the House held back \$182.2 million for 76 projects. The "Sprinkle List" process is mainly shielded from the public, but lobbyists and advocates commonly see it as a last-ditch way to get funding for a project that might have slipped through the cracks during budget negotiations. Projects on the "Sprinkle List" that end up in the budget are still subject to the governor's veto power.
