## **NAIOP Florida Wins Capitol Dome Award and**

## **Announces Newly Elected 2022 Officers & Directors**

**ORLANDO, FLORIDA.** (February 8, 2022) – The Florida chapter of NAIOP, the Commercial Real Estate Development Association, representing commercial real estate developers, owners and related professionals in office, industrial, retail and mixed-use real estate, has won the NAIOP National Capitol Dome Award and announced its newly elected officers and directors for 2022, led by president Clayton Bricklemyer.

NAIOP Florida is the proud recipient of the Capitol Dome Award for 2021. The pandemic limited the personal interaction and relationship building between state lawmakers and the public last year, but this did not stand in the way of NAIOP Florida members from achieving several legislative victories. In fact, last year was one of their most successful yet for advocacy.

Members participated in multiple virtual meetings with lawmakers that resulted in successful policy outcomes for NAIOP and commercial real estate. This state will now:

- Collect sales tax on internet transactions
- Reduce the business rent tax from 5.5% to 2%, one step closer to its elimination.
- Enact local permit reforms, such as electronic filing of applications and the reduction in permit fees if statutory deadlines for review are not met.
- Delay implementation of radio-strength upgrades for first responders within commercial buildings until 2024 in order to allow for technological advancements that are expected to reduce costs.
